



The planning method of obtaining "tax saving" tax benefits as much as possible

税务筹划是指在税法规定的范围内,通过对经营、投资、理财等活动的事先筹划和安排,尽可能的获得"节税"的税收利益的筹划方法。它具有合法性、筹划性、目的性、风险性和专业性的特点。

税务筹划的直接目的就是降低税负,减轻纳税负担。一是选择低税负,低税负意味着较低的税 收成本,较低的税收成本意味着高的资本回报率;二是合理滞延纳税时间获取货币的时间价值。 通过专业技巧,在资本运作方面做到提前收款、延缓支付,避免高边际税率或减少利息支出。



#### The direct purpose of tax planning is to reduce the tax burden

Tax planning refers to the planning method to obtain "tax saving" tax benefits as much as possible through the prior planning and arrangement of business, investment, financial management and other activities within the scope of the tax law. It has the characteristics of legitimacy, planning, purpose, risk and professionalism.

The direct purpose of tax planning is to reduce the tax burden. First, choose low tax burden, which means lower tax cost and higher return on capital; Second, it is reasonable to delay tax payment to obtain the time value of money. Through professional skills, we can collect money in advance and postpone payment in terms of capital operation to avoid high marginal tax rate or reduce interest expenditure.
